3. Business arising from the 2022 Minutes:

This had not been clarified in the 2022-23 Annual Report, and Zara Kimpton requested that the death of a Lifetime Friend be mentioned in the Annual Report in future.

8. President's Report

The President commenced by acknowledging the debt owed to his predecessor and AIIA VIC Life Member Patrick Moore, for his vision for a new future of the Institute.

He thanked the team who under the leadership of Vice-President John Richardson had overseen the process of selling Dyason House and moving to Collins Street.

The contribution of all the interns and volunteers who give their time to do an enormous amount of work for the Institute was recognised.

We are reviewing our membership structure and rates, which have remained unchanged for over five years. Further details will be made available to members in due course. In the meantime, under Council member Mohammad Chowdhury a strategy is being developed to leverage the new CBD location to increase our footprint within the corporate sector and make ourselves more relevant to the Melbourne business community.

While the long-term intention is that the Institute may again buy its own property, the proceeds of the sale of Dyason House are being been invested professionally by LGT Crestone, in a slow and strategic entry to the market. The lease on Collins Street is for

three years with an option for a further three, so there is time to assess the CBD location.

It was intended to resume overseas Study Tours in FY 2023-24.

Finally, the members of the Institute were thanked for their great interest and continuing support, despite the temporary upheavals of the move, as we look forward to the Centenary of AIIA VIC in June 2025.

The President concluded by acknowledging his thanks to another of our Life Members, and former President Zara Kimpton OAM. It was gratifying to note that Zara's contribution to the Institute both in Victoria and nationally over many years had recently been recognised her recently appointment as a Fellow of the AIIA.
